

**Regulations for the payment of the scholarship to participants  
of the Intensive International Curriculum  
under the the "Polish-European School of Law" project,  
implemented by the University of Bialystok as part of the SPINAKER program,  
financed by the Polish National Agency for Academic Exchange  
in accordance with the agreement for funding No. BPI/SPI/2021/1/00034/U/00001**

**GENERAL PROVISIONS**

§ 1

1. These Regulations define the rules for payment of the scholarship and covering the costs of local transport to foreign students/doctoral students participating in two editions of the Intensive International Curriculum (IIC) under the project "Polish-European School of Law" (PESP), co-financed by the National Agency for Academic Exchange in accordance with the agreement on funding no. BPI/SPI/2021/1/00034/U/00001, implemented by the University of Bialystok, under the SPINAKER Program - Intensive International Curriculum.
2. The SPINAKER Program - Intensive International Curriculum is co-financed by the European Social Fund under the Knowledge Education Development Operational Program (PO WER), a non-competition project entitled "Supporting the institutional capacity of Polish universities through the creation and implementation of international study programs" (no. POWR.03.03.00-00-PN16 / 18), Priority axis III "Higher education for the economy and development", Action 3. 3. Internationalization of Polish higher education".
3. The project is implemented in the period from 01.06.2022 to 31.08.2023.

§2

1. The scholarship referred to in §1 sec. 1 in the amount of 5000 PLN is available to foreign students/doctoral students, qualified by the Admissions Commission to one of the two planned editions of the PESL.
2. In total, the scholarship may be paid to a maximum of 40 foreign students/doctoral students, referred to in sec. 1.

3. The scholarship may be paid to the participant referred to in sec. 1, provided that:
  - a) the original declarations and statements required in the project are submitted to the International Cooperation Office;
  - b) concluding an agreement on participation in the Polish-European School of Law;
  - c) take part in min. 90% of PESP classes conducted remotely via the Internet.
4. The scholarship referred to in sec. 1 is paid to foreign students / doctoral students participating in IIC in the first week of the stationary part of PESP, in cash, at the cash desk of Bank Millenium SA, on the basis of an electronic payment order prepared by the Financial Office, at the request of the project coordinator.

### § 3

1. Local transport costs of foreign students/doctoral students participating in the PESL and receiving the scholarship referred to in §1 sec. 1 will be covered in the form of a bearer season ticket of the Bialystok City Transport.
2. The ticket referred to in sec. 1 the coordinator provides the participants with PESL on the first day of stationery classes.

### FINAL PROVISIONS

### § 5

1. The Regulations come into force on the day of announcement and are valid until the end of the Project implementation.
2. The Beneficiary reserves the right to change the regulations.
3. The Project Participant confirms in writing that he has read the regulations and compliance with their rules.
